NOTICE OF DEPOSITION BY VIDEO

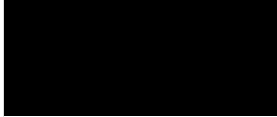

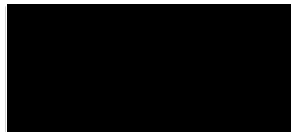
