SERVICE DELIVERY OVERSIGHT COMMITTEE VIRTUAL MEETING MINUTES
FEBRUARY 9, 2022**

The Service Delivery Oversight Committee of the Fairfax-Falls Church Community Services Board met electronically due to the COVID-19 pandemic that has made it unsafe to physically assemble a quorum in one location or to have the public present. Access was made available via video and web conferencing platform to CSB Board members, CSB staff, and members of the public. The meeting notice, including participation instructions, was posted electronically and on the building in which the meeting is typically held. Additionally, attendees were offered an opportunity to register for public comment during the 30 minutes prior to the meeting being called to order.

6. Associate Member Reports, Updates, and Concerns

Associate Member Heather Peck of Laurie Mitchell Empowerment and Career Center reported on the statewide group known as ASPIRE (Advancing State Policy Integration for Recovery and Employment) which is run by Virginia DARS (Department for Aging and Rehabilitative Services) and DBHDS (Department of Behavioral Health and Developmental services). Noted that the Fairfax Falls-Church CSB is an early adopter of IPS (Individual Placement and Support) supported employment, making it one of two in all of Virginia. Provided credit to her colleagues in Laurie Mitchell Empowerment and Career Center, ServiceSource, Psychiatric Rehabilitation Services, and Melwood for this great victory for individuals who are in recovery in the CSB.

7. Discussion of Workforce Recruitment Efforts

Assistant Director Barbara Wadley-Young mentioned receiving positive feedback from George Mason University in collaborating with the CSB and community partners in regard to helping identify points of contacts for specific recruitment efforts such as education, policy and administrative practice, and internships at the micro and macro level. Further meetings took place with Fairfax County Public Schools to discuss the participation of the CSB and community partners in career week panels, jobs fairs, mentorships, and internships which would allow the opportunity for students to be exposed to this field. The Fairfax County Public Schools also recommended to partake in an open house and provide information in careers of working with individuals who have Developmental Disabilities to the Best Buddies Program (which has close to 100 mentors). Other meetings were held with the Department of Family Services to discuss employment opportunities such as peer orientation and relief services for entry level positions for adults and youth in their programs. Collaboration between the VIVA coordinator and GMU School of Social Work are working together to find an individual who might be interested in helping with the coordination and organization of the administrative tasks for the workforce recruitment efforts in exchange for course work hours.

8. Legislative Updates

Deputy Director of Clinical Operations Lyn Tomlinson noted the legislative updates will be discussed in detail during the breakout sessions, with updates being provided to each specific group (Behavioral Health and Developmental Disability).

9. Breakout Sessions

Members were divided into two breakout sessions for 20-minute discussions.

- A. **The Behavioral Health Session was hosted by Deputy Director of Clinical Operations Lyn Tomlinson and Assistant Director Georgia Bachman.**
- B. **The Developmental Disability Session was hosted by Assistant Director Barbara Wadley-Young.**

All members returned to the main meeting and noted discussions on insufficient funding received to fully operate services provided to the CSB and community partners. Also noted difficulties in receiving COVID-19 Federal funding, with many organizations receiving the funding very late. Members also noted their concern for current legislation which is trying to fix certain complications but not address the root cause problem.
