Fairfax County Electoral Board  
January 3, 2023

The Fairfax County Electoral Board (Board) met on Tuesday, January 3, 2023, in Conference Room 315 at the Fairfax County Government Center located at 12000 Government Center Parkway, Fairfax. Chairman Hon. Katherine K. Hanley; Vice Chairman Jeffrey K. Shapiro; Secretary Amb. (ret.) Christopher P. Henzel; General Registrar Eric L. Spicer; Deputy Registrar Cheryl Jones; and Clerk to the Electoral Board Beth Dixon Methfessel were present.

IT Manager Cord Whitehouse; Election Operations Manager Ravi Udeshi; Election Equipment and Logistics Manager Tyrone Allen; Voter Registration Supervisor Bushra Ardalan; Absentee Voting Manager Sean Stewart; Supply Manager Kay Garrison; Public Information Officer Brian Worthy; Antemira Elliott and Jean Thoensen (Office of Elections staff); Gregory Brandon (Fairfax County Democratic Committee Central Communications); Richard Weiss (FCDC Voter Registration and Education); Maggi Luca (Fairfax, League of Women Voters – (Fairfax LWV)); and Andrea Bayer and Barbara Palmer-Tengs (members FCRC); and (Fairfax County election officer and/or resident of Fairfax County) also attended the meeting in person.

Mr. Henzel called the meeting to order at 4:03 p.m. and introduced himself, Ms. Hanley, and newly sworn-in Board member Jeffrey Shapiro.

Ms. Hanley moved approval of the Draft Minutes of the Board meeting held on December 12, 2022. By a vote of 2-0 (with Mr. Shapiro abstaining), the Minutes of the Board meeting held on December 12, 2022, were adopted.

Mr. Henzel called for the reorganization of the Board. Mr. Henzel moved that Katherine Hanley be elected to the position of Chairman. The motion passed by a vote of 3-0. Ms. Hanley moved that Jeffrey Shapiro be elected to the position of Vice Chairman. The motion passed by a vote of 3-0. Mr. Shapiro moved that Christopher Henzel be elected to the position of Secretary. The motion passed by a vote of 3-0.

Under the Chairman's report, Ms. Hanley explained that redistricting "clean-up" for the precincts and polling places continues, and she summarized the 2023 changes that will be submitted to the Board of Supervisors (BOS) in February to authorize a public hearing in March. These changes include renaming Franconia #1 and #2 to Edison #1 and #2; moving Spindle #2

from the Centreville Library to Bull Run Elementary School and renaming it Robinson Mill; moving Difficult Run's polling place from the Church of the Good Shepherd to the U.U. Congregation of Fairfax; and splitting the Tysons precinct with more than 5,000 registered voters to relieve the current polling place that is not large enough to sustain the continued growth of the Tysons area. Mr. Henzel asked if staff is currently working on the split of the Tysons precinct. Ms. Hanley explained that the County owns the old container store now called the Parc at Tysons. A meeting will be held on Thursday, January 5 to determine whether this location can serve as a polling place. Ms. Hanley added that the Clerk to the Board oversees the creation and submission of precinct and polling place changes to the BOS.

Under the Vice Chairman's report, Mr. Shapiro thanked staff for their warm welcome and courteous assistance.

Under the Secretary's report, Mr. Henzel reiterated his appreciation for the cooperation and lack of partisanship exhibited during his first year on the Board and expressed his optimism that this will continue under the new configuration of the Board.

Under Public Comments, Ms. Hanley explained that public comments should be no longer than three minutes. Ms. Bayer asked for clarification that the Tysons precinct would be split. Ms. Hanley confirmed that the recommendation is that the Tysons precinct be divided into two precincts with separate polling places to relieve the current polling place that cannot sustain a precinct with more than 5,000 voters.

There being no further business, Mr. Henzel moved to adjourn. The motion carried, and without objection, the meeting was adjourned at 4:10 p.m.

MINUTES  
Fairfax County Electoral Board  
January 11, 2023

The Fairfax County Electoral Board (Board) met on Tuesday, January 3, 2023, in Conference Room 315 at the Fairfax County Government Center located at 12000 Government Center Parkway, Fairfax. During the meeting, the Board received the election materials necessary to canvass the returns and ascertain the results of the Special Election, 35<sup>th</sup> House of Delegates, held on January 10, 2023. Present were Chairman Hon. Katherine K. Hanley; Vice Chairman Jeffrey K. Shapiro; Secretary Amb. (ret.) Christopher P. Henzel; General Registrar Eric L. Spicer; and Clerk to the Electoral Board Beth Dixon Methfessel. In addition, rovers and Office of Elections (Office) were present to conduct the Canvass.

Ms. Hanley called the meeting to order at 10:05 a.m. and introduced the Board. She welcomed the Canvass workers, authorized party representatives, and observers. Ms. Hanley reviewed the agenda, and then asked the Elections Operations Manager Ravi Udeshi to give instructions on conducting the Canvass. Mr. Udeshi explained how to complete the Canvass Checklist (attached and made a part of this record) to the four assembled teams. The Canvass was divided into two phases to be completed concurrently. In the first phase, the teams verified the election results. This part included organizing, reordering, and verifying the completion of the machine tapes, comparing the machine tapes to the ERM (Election Results Management-ElectionWare), and confirming that the statements of results were completed properly. In the second phase of the canvass, the teams reviewed all the forms and signatures to ensure that they were returned, completed, and signed (where required). Any issues or problems regarding the Canvass were brought to the Board's attention. The Chief's Notes were set aside for Board review.

At 11:45 a.m. the Canvass concluded for all 20 precincts, as well as the voter satellite office and the Fairfax County Government Center.

At 12:00 p.m. in Conference Room 232, the Electoral Board convened the provisional part of the Canvass as required by Va. Code § 24.2-653 to allow voters casting provisional ballots in the January 10, 2023, Special Election, to present any information that might prove they are qualified, registered voters in the precinct where they cast their provisional ballot. As Ms. Hanley noted that no provisional voters appeared to present their qualifications or any other relevant information to be considered by the Board. If a provisional voter would like to appear before the Board, the Board will reconvene on Saturday, January 14, 2023, at 10:00 a.m. to allow them to present their case.

At 12:04 p.m. Ms. Hanley recessed the Canvass.

Saturday, January 14, 2023  
Reconvened Canvass and Provisional Ballot Meeting

At approximately 10:00 a.m. the Electoral Board reconvened the Canvass in Conference Room 315/319 as required by Va. Code § 24.2-653 to allow voters casting provisional ballots in the January 10, 2023, Special Election to present any information that might prove they are

qualified, registered voters in the precinct where they cast their provisional ballot. No provisional voters appeared in person.

At 10:05 a.m. Ms. Hanley moved that the Board enter a Closed Session for the purpose of considering whether each person who submitted a provisional vote at the election was qualified to do so. Other than appropriate staff and legal counsel of the Electoral Board, attendance at this meeting shall be permitted for the persons whose provisional votes are being considered with their legal counsel, if present, as well as one authorized representative of each political party or independent candidate, as specified in §24.2-653(B). The authorized representative for the Fairfax County Republican Committee (FCRC) was Christine Brim; there was no authorized representative for the Fairfax County Democratic Committee (FCDC).

At 10:30 a.m. the Board concluded the Closed Session. Ms. Hanley moved that the Fairfax County Electoral Board certify that in the Closed Session just concluded, the only matters discussed were the qualifications of provisional voters, as permitted by Virginia Code § 24.2-653, and as identified in the motion to close the meeting pursuant to the Virginia Freedom of Information Act. The motion passed by a vote of 3-0.

Ms. Hanley moved that **84** out of the 89 Provisional Ballots cast and entered as qualified on the Master Provisional Ballot Log be **accepted and counted** for the reasons determined by a majority vote of the Electoral Board. The Provisional Ballot Log shall be retained and incorporated into the Minutes of the Canvass for the January 10, 2023, Special Election. The motion passed by a vote of 3-0.

Ms. Hanley moved that the remaining **5** out of the 89 Provisional Ballots cast and entered as disqualified on the Master Provisional Ballot Log be **rejected** for the reasons determined by a majority vote of the Electoral Board. The Provisional Ballot Log shall be retained and incorporated into the Minutes of the Canvass for the January 10, 2023, Special Election. The motion passed by a vote of 3-0.

The 84 qualified provisional ballots were extracted and scanned on the DS200. Once completed, the results were uploaded into ERM (Fairfax County's election results management system).

The Canvass of the Central Absentee Precinct commenced at 10:34 a.m. and was completed at 10:55 p.m.

Once the results from the provisional adjudication and the CAP Canvass were uploaded and verified in the ERM system, the Board completed the Statement of Results for the qualified provisional voters for the January 10, 2023, Special Election. The Board then certified the results of the election. The Board signed the Abstracts that were then sent electronically for review to the Department of Elections.

Mr. Henzel moved that there being no further business, the Board conclude the January 10, 2023, Special Election. By a vote of 3-0, and without objection, the Board adjourned at 12:23 p.m.

## **Fairfax County Voter List**

### **Confirmation Mailings and Cancellation Process**

Pursuant to state law (§ 24.2-428) and the National Voter Registration Act (NVRA), the Virginia Department of Elections (ELECT) conducts an annual address match of Virginia’s voters against records in the United States Postal Service’s (USPS) National Change of Address (NCOA) registry, which is a process that is conducted as part of ELECT’s membership in the Electronic Registration Information Center (ERIC).

ELECT enters voters in the Commonwealth of Virginia into the confirmation mailing process when they determine that the voter has moved and their new address differs from their current Virginia registration address in the statewide voter database (VERIS).

These confirmation mailings include a postage prepaid envelope and a form for voters to use to inform us of their current residence address and, if they have moved out of state, request their registration be cancelled. Voters who respond to the mailing within 30 days and confirm that their residence is unchanged or is in Virginia remain on the voter registration list as active, Virginia-registered voters.

Voters who do not respond to the notice within 30 days or whose confirmation mailing is returned as undeliverable are classified as “Inactive” on the voter’s registration record in VERIS. Inactive voters are removed automatically from VERIS if they fail to vote or update their Virginia voter registration address over a period of two federal general elections (2 to 4 years).

Voters who have been designated as “Inactive” may still cast a ballot on Election Day. These voters are required to sign a statement declaring that they are a qualified and registered voter of the precinct at which they are present before casting their ballot.

### **Confirmation Mailing Time Frame**

ELECT has indicated that they will initiate two confirmation mailings in 2023. The first confirmation mailing is scheduled to be sent to Fairfax County voters during the first week of February.

### **Recent Cancellations**

On January 27, ELECT (automatically, through VERIS) canceled the registration of 6,656 voters in Fairfax County who were placed in “Inactive” status on or before August 8, 2020, did not respond to multiple notices, had not voted in any election, and had not updated their Virginia voter registration address between August 8, 2020, and January 18, 2023. We will send the cancellation list to each political party, post the list at the Fairfax County Courthouse, or publish it in the newspaper, and have a copy available in our office for public inspection.

## **Polling Place Changes**

At the February 21, 2023, meeting of the Board of Supervisors, the Office of Elections will request a public hearing on March 21, 2023, to make the following changes:

1. Change name of 432 Franconia #2 precinct to #432 Edison #2
2. Change name of 732 Oak Marr precinct to #732 Oaktree Crossing
3. Change name of 924 Spindle #1 precinct to #924 Spindle
4. Change name of 935 Spindle #2 precinct to 935 Robinson Mill

The following changes will also be considered and if adopted, will take effect upon receipt of a Certification on No-Objection from the Attorney General (expected no later than May 21, 2023):

5. Divide 731 Tysons precinct to create 738 Jones Branch precinct with its polling place established at Providence Committee Meeting Room
6. Move the polling place for 731 Tysons precinct to The Parc at Tysons
7. Move the polling place for 929 Difficult Run to the U.U. Congregation of Fairfax Church
8. Move the polling place for 935 Spindle #2 precinct to Bull Run Elementary School

Also on February 21, 2023, the Board of Supervisors will adopt a resolution to apply to the State Board of Elections for a waiver to administer Pioneer, Garfield, Penderbrook, and Burke # 2 precincts, as split precincts. Because a waiver only applies for elections held in the year the waiver was granted, the Board of Supervisors must confirm its decision to again seek a split precinct waiver for 2023.

## **District Name Change**

We will mail notices to all voters impacted by the Lee to Franconia District name change informing them that district boundaries remain the same and that only the name changed from the Lee District to the Franconia District.

## **Notices to Voters for Polling Place Changes and District Name Change**

We will send notices to the impacted voters at least 15 days before the June Primary Election as required by § 24.2-306 of the Code of Virginia.

## **Legislation**

We have been and will continue to follow state legislation in the Virginia House of Delegates and Virginia Senate. Pat Ferguson and Cheryl Jones on my staff have put in a great deal of effort tracking legislation.

---

## **Campaign Finance Training**

We hosted a campaign finance class in Conference Room 9-10 at the Government Center and online on Saturday, January 28, that was conducted by staff from ELECT. We notified four political parties, Fairfax County supervisors, nine Northern Virginia registrars and known Fairfax County candidates about this opportunity. We also posted information about the training on our website.



---

### **Appointment of Election Officers**

As required by Virginia Code § 24.2-115, we will re-appoint election officers this year for a new two-year term that begins on March 1, 2023.

We received nomination lists from the Fairfax County Republican Party and the Fairfax County Democratic Party, which comprise the bulk of the re-appointment list. The Electoral Board is required to meet during the first week of February to appoint these officers.

After being re-appointed, election officers must complete a new oath form. In past years, election officers were mailed a paper oath form, which then had to be returned by mail or in-person. This year, we will instead use a secure digital service to electronically send and collect all oath forms. This will save significant staff time and reduce costs, while also greatly simplifying the process for election officers.

All election officers are required to complete new training during each appointment term. Training for Election Day election officers will be available approximately two months before each election.

### **Information on Primary and General Elections and Offices on the Ballot for 2023**

Each political party will determine their method for nominating their candidates for the November 2023 General Election. If they choose to conduct a primary election, it will be held on June 20, 2023. If both political parties have primary elections, then each party will have a distinct ballot, and the elections will be conducted and reported by party.

The general format of primary election ballots will follow that of the June 2022 primary election with the name of the party at the top of the ballot. I will provide samples of the November 2019 ballot and the June 2022 ballot at the Board Meeting.

---

**FY 2024 Budget**

---

In November 2022, we submitted our request for the FY 2024 Budget including requests for additional funding for critical services. Historically, the Office of Elections has been underfunded and funding has been added each year during the third quarter of the fiscal year. We have been working with staff in the Department of Management and Budget (DMB) during the past year to right-size our budget and they have provided valuable assistance. The county's proposed budget will be released in February.

While working on our FY 2024 Budget, we made changes to our budget narrative to more accurately reflect what we are doing, recent accomplishments, and future challenges. Also, while we could not change or add to our performance measurements, we made adjustments to improve their accuracy. For example, one measurement reflected an error rate of 2.0% to 2.9% for voter registration transactions. The actual error rate was between .03% and .04%. For example, we had 88 errors last year out of over 300,000 transactions, and the incorrect measurements made it seem like we had more than 6,000 errors. In the future, we look forward to improving our performance measurements.

We are working on third quarter requests to provide additional funding that is needed in the current fiscal year to provide essential services.


