Mobile Food Vending Zone Agreement (2019)

Only a mobile food truck or mobile food trailer with a valid Fairfax County Department of Health Food Establishment Permit may operate as a Mobile Food Vendor within Mobile Food Vending Zones (VDOT rights-of-way) established by the County. This agreement includes a checklist of the specific requirements for operating within Mobile Food Vending Zones. The owner must agree to comply with each of the requirements. The Health Department may request additional documentation. This agreement is valid for one calendar year or portion thereof. **A pushcart shall not operate in Mobile Food Vending Zones.**

MOBILE FOOD VENDING DEFINITIONS

Mobile Food Vending: The sale, display, solicitation or offer for sale, barter, exchange, gift or otherwise of food, as defined in Chapter 43.1 of the Fairfax County Code, from the curb side of a self-contained vehicle or trailer that is legally parked in a single parking space on a public street to pedestrian customers on the curbside of a Mobile Food Vending Zone (Zone), as set forth in Chapter 82 of the Fairfax County Code.

Mobile Food Vendor: Any individual that operates or assists in the operation of a motor vehicle in the sale, display, solicitation for sale, barter, exchange, gift or otherwise of food from a vending motor vehicle parked on marked or signed streets within a Zone.

LUP-MFV: The Virginia Department of Transportation (VDOT) Land Use Permit (LUP) for Mobile Food Vending (MFV) issued to Fairfax County.

Mobile Food Vending Zone: A street or portion of a street designated by Fairfax County that meets all the requirements of the VDOT LUP-MFV. These streets and locations are marked or signed to identify them as authorized locations for mobile food vending operations.

MOBILE FOOD VENDING REQUIREMENTS

Please review the following list of requirements that must be met and maintained in order to operate as a Mobile Food Vendor. Initial the box on the left side of each requirement to indicate that you have read and understand the requirement.

- The current Fairfax County Department of Health Food Establishment Permit and a copy of the LUP-MFV must be displayed in plain view on the exterior or the interior of the Mobile Food Vending vehicle.**
- The Mobile Food Vendor must secure and provide proof of insurance to protect against liability for personal injury and property damage up to one million dollars (\$1,000,000) for each occurrence and two million dollars (\$2,000,000) aggregate. Fairfax County, Virginia, must be named as an additional insured. This insurance must remain valid as long as the permit holder occupies state maintained highway rights-of-way in accordance with the permit. **Proof of this insurance shall be maintained in the Mobile Food Vending vehicle and made readily available for inspection by the County and/or VDOT.**
- Mobile Food Vending operations may be conducted for a maximum of four (4) hours on any one (1) day at any one (1) location, including parking the vehicle or trailer, set-up and break-down of operations. **Parking and vending twice in one day within the same block of a public street shall not be permitted.** Upon completion of the four hour window of operations, or completion of break-down of operations, whichever occurs earlier, the Mobile Food Vending vehicle or trailer must be moved or removed from the location from which such vehicle or trailer was operating. **There shall be no exceptions to this time limitation.**
- Mobile Food Vending parking and operations shall be prohibited between the hours of 10 p.m. and 7 a.m. the following day. No vending operations shall be permitted prior to 9 a.m. on Sundays or federal holidays.**
- Mobile Food Vendors shall ensure that the vicinity around the Mobile Food Vending vehicle is kept clean and free of trash and debris.** The vendor must provide trash receptacles in the immediate area of the vehicle, shall request customers to place all waste and litter in the receptacles, and shall remove and properly dispose of all waste and litter in the vicinity of the vehicle.
- No tables, seating, umbrellas, propane tanks, generators, cooking implements, signs or other accessories are allowed on the ground outside of the Mobile Food Vending vehicle.**
- The operation of any loudspeaker or other sound amplification device from, within, or in the immediate vicinity of any Mobile Food Vending vehicle is prohibited.**

CERTIFICATION STATEMENT

I hereby agree to comply with the Mobile Food Vending requirements. I understand the Virginia Department of Transportation (VDOT) and Fairfax County have reserved the right to suspend any or all mobile food vending operations on state maintained highway rights-of-way in response to public safety or operational concerns. VDOT and the County shall be held harmless from any resulting monetary losses by the Mobile Food Vendors resulting from such suspension.

APPROVED MOBILE FOOD VENDING LOCATIONS

Street Name	Location Description
Boone Boulevard	Tysons: North side of Boone Boulevard just west of Howard Avenue
Corporate Court	Springfield: East side of Corporate Court off of Boston Boulevard
Dulles Technology Drive	Herndon: South side of Dulles Technology Drive at the northern intersection with Sunrise Valley Drive
Howard Avenue (1)	Tysons: East and west sides between Old Courthouse Road and Boone Boulevard
Howard Avenue (2)	Tysons: East and west sides north of Boone Boulevard
Pinnacle Drive	Tysons: East and west sides of Pinnacle Drive north of the intersection with Pinnacle Drive

Note: Mobile food vending locations will have signage stating "Food Trucks Allowed." Trucks and trailers must be parked in spaces between these signs. Vendors must obey ALL signage posted at each mobile food vending location.
